Pursuant to Regulation 30 read with Clause no. 20 of Para A of Part A of Schedule III of the Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 (“SEBI Circular”), this is to inform that in the ongoing litigation between **Honasa Consumer Limited (Company/Petitioner in this case) and RSM General Trading LLC (Respondent)** where RSM General Trading LLC had filed a lawsuit in the Dubai Court for unlawful termination of its distributorship by Honasa Consumer Limited. In furtherance of the same, The Company and RSM had filed respective appeals before Court of Appeal (Dubai), challenging the judgment passed by the Court of First instance. The Court of Appeal (Dubai) has passed an order on October 15, 2024 (the translated copy of the order was received by the Company on October 18, 2024) rejecting both the appeals and upheld court of first instance judgement dated May 16, 2024.

The details of the orders, as required under Regulation 30 of the Listing Regulations read with SEBI Circular dated July 13, 2023, is enclosed herewith as an Annexure – 1.

Further, the Dubai Court has ordered both the parties to pay appeal costs of AED 1000.</p> <p>Honasa will file an appeal against the judgement of the Dubai Court in 30 days before the Cassation Court at Dubai (“Supreme Court”).</p> <p>Further, the appeal costs of AED 1000 is not final till the Cassation Court at Dubai passes its final judgement.</p>
