US foiled plot to kill Khalistan separatist, warned India: Report

THE UNITED STATES "thwarted a conspiracy to assassinate" Khalistan separatist Gurpatwant Singh Pannun on American soil and "issued a warning to India's government over concerns it was involved in the plot," the UK-based daily, *Financial Times*, has reported, citing multiple sources.

This comes two months after Canadian Prime Minister Justin Trudeau alleged that Canadian security agencies were probing "credible allegations" about a potential link between Indian government agents and the killing of Khalistan separatist Hardeep Singh Nijjar in Vancouver in June.

While the Indian government has rejected Canada's allegations as "absurd" and "motivated", there has been no official statement from the government on the FT report so far.

When asked about the report, the spokesperson for the US Embassy in New Delhi said, "We do not comment on diplomatic, law enforcement, or intelligence discussions with our partners."

According to the report, the US, Canada and allies shared details — the US, UK,

Australia, New Zealand and Canada are part of the intelligence-sharing network "Five Eyes" — and the Nijjar killing and the Pannun assassination plot sparked concerns "about a possible pattern of behaviour" on Delhi's part.

"Washington shared details of the Pannun case with a wider group of allies after Trudeau went public with details of the Vancouver killing, the combination of which sparked concern among allies about a possible pattern of behaviour," it said.

The FT report said the US protest was issued after Prime Minister Narendra Modi's state visit to Washington in June this year. It was not clear "whether the protesters to New Delhi led the plotters to abandon their plan, or

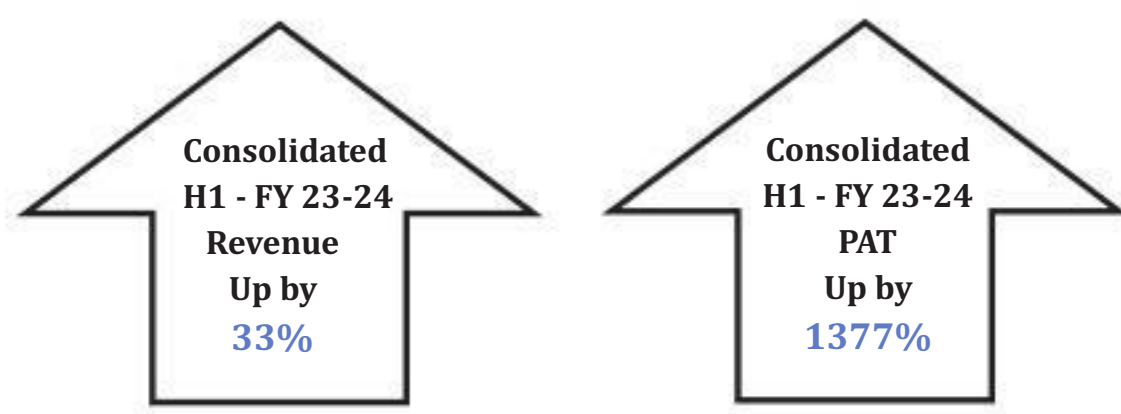
whether the FBI intervened and foiled a scheme already in motion," it said.

Separate from the diplomatic warning, US federal prosecutors have filed a sealed indictment against at least one alleged perpetrator of the plot in a New York district court, FT said, quoting sources.

"The US justice department is debating whether to unseal the indictment and make the allegations public or wait until Canada finishes its investigation into Nijjar's murder. Further complicating the case, one person charged in the indictment is believed to have left the US," it said.

The report said the US justice department and FBI declined to comment on the matter. "The National Security Council said the US does 'not comment on ongoing law enforcement matters or private diplomatic discussions with our partners' but added: 'Upholding the safety and security of US citizens is paramount,'" it said.

The report said Pannun "declined to say whether US authorities had warned him about the plot, saying he would 'let the US government respond to the issue of threats to my life on American soil from the Indian operatives'.

Diplomatic thaw: India resumes e-visa facility for Canadians

ALMOST TWO MONTHS after it suspended visa services in Canada over its Prime Minister Justin Trudeau's allegation of a potential Indian link to the killing of Canada-based Khalistan separatist Hardeep Singh Nijjar, India resumed e-visa services for Canadian nationals on Wednesday.

"Indian eVisa facility has been restored with effect from 22 November 2023, for all eligible Canadian citizens," the Indian High Commission in Ottawa tweeted.

Last month, India had restored visa services in some categories including

entry visa, business visa, medical visa and conference visa. But tourist visas have still not been restored for Canadian citizens.

"The visa services have been opened partially, but it has not been normalised," an Indian government source said.

But this is still being perceived as a major de-escalatory move by India, a potential "door-opener" though Trudeau and his government have not withdrawn his allegation, which was dismissed by Delhi as "absurd" and "motivated".

Earlier, when India had suspended visa services, New Delhi had said the High Commission of India in Ottawa

and its Consulates General in Toronto and Vancouver were constrained to take the decision because of safety and security considerations.

Following the diplomatic spat, Delhi had asked Ottawa to reduce its diplomatic presence in India. Last month, Canada had announced that it had pulled out 41 diplomats from India and halted its visa and consular services in Chandigarh, Mumbai and Bengaluru, and these services would now be available only at the Canadian High Commission in Delhi.

Canada is the fourth biggest source of foreign arrivals in India. In 2021, it accounted for 5.3% (80,437) of foreign tourist arrivals.

दिल्ली उच्च न्यायालय ने कहा है कि कमाने की योग्यता रखने वाले पति या पत्नी को बेरोजगार रहने और खर्चों का बोझ अपने जीवनसाथी पर डालने की अनुमति नहीं दी जा सकती। न्यायालय ने कहा है कि एक पति या पत्नी जिसके पास कमाने की उचित क्षमता है, लेकिन पर्याप्त स्पष्टीकरण के बिना वह बेरोजगार रहना चाहते हैं तो उन्हें दूसरे साथी पर भरण-पोषण के खर्चों को पूरा करने की एकतरफा जिम्मेदारी डालने की अनुमति नहीं दी जानी चाहिए। उच्च न्यायालय ने एक व्यक्ति द्वारा अलग रह रही अपनी पत्नी को हिंदू विवाह अधिनियम (एचएमए) के तहत दिए जाने वाले मासिक भरण-पोषण की राशि को 30,000 रुपये से घटाकर 21,000 रूपए करते हुए टिप्पणी की। अदालत

ने कहा कि महिला ने दावा किया है कि उसके पास आय का कोई स्रोत नहीं है, लेकिन दिल्ली विश्वविद्यालय से स्नातक होने के कारण उसकी शैक्षिक पृष्ठभूमि उचित है।

न्यायमूर्ति वी कामेश्वर राव और न्यायमूर्ति अनूप कुमार मेंदिरता की एक पीठ ने कहा कि ऐसे पति या पत्नी जिनके पास कमाने की उचित क्षमता है, लेकिन जो बिना किसी पर्याप्त स्पष्टीकरण या रोजगार हासिल करने के अपने इमानदार प्रयासों का संकेत दिए बिना बेरोजगार रहना पसंद करते हैं, उन्हें अपने खर्चों को पूरा करने की एकतरफा जिम्मेदारी दूसरे पक्ष पर डालने की अनुमति नहीं दी जानी चाहिए। उच्च न्यायालय में निचली अदालत के आदेश को चुनौती दी गई थी। निचली अदालत ने व्यक्ति को अपनी अलग रह रही पत्नी को 30,000 रुपये मासिक गुजारा भत्ता और 51,000 रुपये मुकदमे का खर्च देने का निर्देश दिया था।

कार्यवाहक मुख्य न्यायाधीश मनमोहन की अध्यक्षता वाली पीठ ने केंद्र को भी जनहित याचिका पर जवाब दाखिल करने के लिए समय दिया। याचिका में आरोप लगाया गया है कि विपक्षी दल ‘इंडिया’ संक्षिप्त नाम का इस्तेमाल कर ‘हमारे देश के नाम का अनुचित लाभ’ उठा रहे हैं। अतिरिक्त सालिसिटर जनरल चेतन शर्मा ने केंद्र सरकार की ओर से कहा कि हमें अपना

जवाब देने के एक सप्ताह से दस दिन का समय और चाहिए।

कांग्रेस, तृणमूल कांग्रेस, द्रमुक समेत नौ राजनीतिक दलों की ओर से पैरवी कर रहे वरिष्ठ अधिवक्ता अभिषेक मनु सिंघवी ने कहा कि याचिका के खिलाफ ‘प्रारंभिक आपत्तियां’ हैं और उच्चतम न्यायालय इस मुद्दे को पहले ही देख चुका है। पिछली सुनवाई में उन्होंने कहा था कि याचिका विचारणीय नहीं है। पीठ में न्यायमूर्ति मिनी पुष्करणा भी शामिल रहें।

पीठ ने मामले में सुनवाई के लिए चार जनवरी की तारीख तय की। याचिकाकर्ता गिरीश भारद्वाज ने उच्च न्यायालय में संपर्क किया था और 26 राजनीतिक दलों द्वारा संक्षिप्त नाम ‘इंडिया’ के इस्तेमाल और इसके साथ राष्ट्रीय ध्वज के उपयोग पर भी रोक लगाते हुए अंतरिम आदेश जारी करने का अनुरोध किया था।

दिल्ली सरकार ने अधिसूचित किया है कि यदि केंद्र सरकार की वायु प्रदूषण नियंत्रण योजना के अंतिम चरण के तहत पार्वदियां लागू की जाती हैं, तो राजधानी में सीएनजी, बीएस4 डीजल और इलेक्ट्रिक बसों को छोड़कर अन्य बसों के प्रवेश को विनियमित किया जाएगा।

चरणबद्ध प्रतिक्रिया कार्य योजना (जीआरएपी) यानि कि ‘ग्रेप’ का चौथा चरण इसका अंतिम चरण होता है। एक आधिकारिक राजपत्रित अधिसूचना में कहा गया है कि जीआरएपी का चौथा चरण लागू होने पर अखिल भारतीय पर्यटक बसों, टैके पर चलने वाली बसों, राज्य परिवहन बसों या सीएनजी इलेक्ट्रिक या बीएस4 डीजल बसों को छोड़कर अन्य राज्यों में किसी अन्य प्रकार के परमित रखने वाली सभी बसों के दिल्ली में प्रवेश पर प्रतिबंध लगा दिया जाएगा।

पिछले महीने, दिल्ली सरकार ने निर्देश दिया था कि इलेक्ट्रिक, सीएनजी या बीएस-चार डीजल से चलने वाली बसों को ही हरियाणा से राष्ट्रीय राजधानी में प्रवेश की अनुमति दी जाए। उत्तर प्रदेश और राजस्थान के राष्ट्रीय राजधानी क्षेत्रों से प्रवेश करने वाली बसों को भी इन मानदंडों का पालन करना होगा।

दिल्ली एनसीआर सहित देश के 34 शहरों की हवा और बिगड़ी, हालात खतरनाक के करीब पहुंच गया है। दिल्ली में बुधवार को सुबह वायु गुणवत्ता सूचकांक (एक्यूआइ) बहुत खराब श्रेणी में दर्ज किया गया।

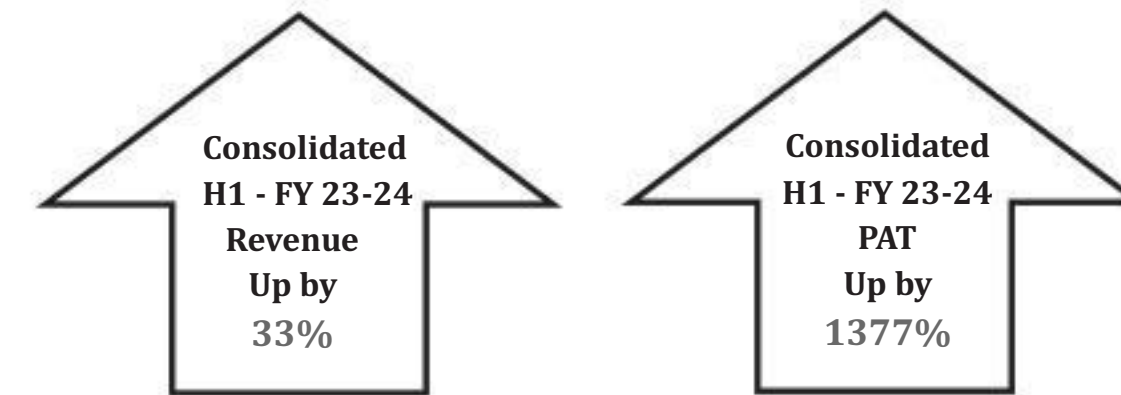
एक्यूआइ सुबह नौ बजकर पांच मिनट पर 394 रहा, जो शाम चार बजे 395 हो गया। जबकि एक दिन पहले मंगलवार को यह 365 था। दिल्ली में न्यूनतम तापमान 10.6 डिग्री

सेल्सियस दर्ज किया गया, जो इस मौसम के सामान्य तापमान से एक डिग्री कम है, जबकि सापेक्ष नमी सुबह आठ बजकर 30 मिनट पर 76 फीसद रही। रविवार को मामूली सुधार के बाद दिल्ली में एक्यूआइ में भारी वृद्धि दर्ज की जा रही है।

शहर का एक्यूआइ सोमवार शाम पांच बजे 348 था, जबकि रविवार को यह 301 से कम दर्ज किया गया था। फरीदाबाद में एक्यूआइ 356, गाजियाबाद में एक्यूआइ 344, गुरुग्राम में 341, ग्रेटर नोएडा में 321 और नोएडा में 341 एक्यूआइ दर्ज किया गया। प्रदूषित हवा पर

एनजीटी की फटकर के बाद भी हालत में कोई बदलाव नहीं आया है, सरकार अभी विचार मंथन में ही लगी है। जबकि 400 पार करते ही एक्यूआइ खतरनाक स्तर पर पहुंच जाएगा। जिसकी काफी आशंका है क्योंकि तापमान में गिरावट के साथ हवा की गति भी धीमी हुई है। प्रदूषण के स्तर में सुधार के मद्देनजर केंद्र ने शनिवार को सार्वजनिक निर्माण से संबंधित एवं निर्माण कार्य पर प्रतिबंध तथा दिल्ली में प्रदूषण फैलाने वाले ट्रकों के प्रवेश पर रोक सहित कड़े प्रतिबंध हटा लिए थे, जिसके बाद से एक्यूआइ के स्तर में वृद्धि हुई है।
