भ्रष्टाचार के मामले में सीबीआइ की कार्रवाई

# दिल्ली परिवहन विभाग के छह अधिकारी गिरफ्तार

नई दिल्ली, 12 फरवरी (भाषा)।

केंद्रीय जांच ब्यरो (सीबीआइ) ने दिल्ली परिवहन विभाग के छह अधिकारियों को भ्रष्टाचार और रिश्वत लेने के आरोप में गिरफ्तार किया है। अधिकारियों ने बुधवार को यह जानकारी दी।

सत्तारूढ़ आम आदमी पार्टी (आप) के हाल में दिल्ली विधानसभा चुनाव हारने के बाद राष्ट्रीय राजधानी में यह पहली बड़ी कार्रवाई है। अधिकारियों ने बताया कि एजंसी को विभाग में व्यापक भ्रष्टाचार के खिलाफ शिकायतें मिल रही थीं। उन्होंने बताया कि गिरफ्तारी से पहले शिकायतों की निगरानी और सत्यापन करने का निर्णय लिया गया। उन्होंने बताया कि शिकायतों के सत्यापन में प्रथम दृष्ट्या विभिन्न स्तरों पर भ्रष्टाचार के संकेत मिले, नतीजतन ये गिरफ्तारियां हुईं। यह कार्रवाई सोमवार रात में की गई। बताया गया कि ये अधिकारी दिल्ली सरकार के परिवहन विभाग से जुड़े हैं। दिल्ली

से लेकर गुरुग्राम सीमा इलाके में रिश्वत लेने वाले दिल्ली सरकार की परिवहन विभाग में कार्यरत अधिकारियों के खिलाफ यह कार्रवाई की गई है। दिल्ली-गुरुग्राम रूट पर, जो बसें चलती हैं। वहां से लगातार यह शिकायतें आ रही थीं कि दिल्ली परिवहन विभाग के अधिकारी हैं वे भ्रष्टाचार का खेल खेल रहे हैं और वहां बड़े पैमाने पर भ्रष्टाचार हो रहा है। शिकायत में यह भी बताया गया कि बसों से अवैध वसली भी की जा रही है। इसके पीछे

# दिल्ली के लिए 100 दिन की कार्ययोजना बनाने में जुटे अधिकारी

सभी विभाग प्रमुखों को यह भी निर्देश दिया गया है कि वे उन योजनाओं या परियोजनाओं के लिए कैबिनेट मसौदा नोट तैयार करना शुरू करें, जिन्हें नई भाजपा सरकार शपथ ग्रहण के बाद शुरू कर सकती है। अधिकारियों ने बताया कि दिल्ली सरकार का सामान्य प्रशासन विभाग (जीएडी) 100 दिनों के लिए कार्ययोजना तैयार करेगा और इसे नई सरकार के समक्ष प्रस्तत मुख्य सचिव के निर्देशानुसार कार्ययोजना में 15 दिन, मासिक और 100 दिन की अवधि में पूरा किए जाने वाले लक्ष्यों पर ध्यान केंद्रित किया जाना चाहिए।
