Dear Sir / Madam,

This is in continuation of our earlier letter dated April 03, 2025, regarding update on an ongoing litigation between Honasa Consumer Limited (“Company”) and RSM General Trading LLC (“RSM”) in Dubai Court. We hereby inform that the Court of Appeal, Dubai, UAE (“Court of Appeal”) has passed a judgment on February 11, 2026 (“Judgement”), translated copy of which was received by the Company on February 16, 2026 at 12:37 pm (IST).

The Company shall file an appeal against the Judgment before the Cassation Court, the Highest Court of Dubai, UAE (“Cassation Court”), within a period of 30 days and in accordance with the UAE procedural laws. The Company had also filed a Petition under section 9 of Arbitration and Conciliation Act, 1996 before Hon’ble Delhi High Court. The Hon’ble Delhi High Court subsequently allowed the petition and granted an anti-enforcement injunction to the Company restraining RSM to enforce any judgment or decree passed by the Dubai Courts.

<p>The details of any change in the status and/or any development in relation to such proceedings</p>	<p>Pursuant to the judgment passed by the Cassation Court, wherein the Cassation Court overturned the earlier Appeal Court Judgement dated 15<sup>th</sup> October 2024 and referred the matter back to the Court of Appeal for a rehearing by a new bench, the Court of Appeal has now passed a Judgment significantly reducing the earlier awarded amount of approx. AED 25 Million to the award amount of AED 1.7 million towards compensation for material and moral damages to RSM.</p> <p>The Court of Appeal also noted that RSM had breached certain contractual obligations, particularly failing to meet expected sales performance during the Agreement term.</p> <p>The Company shall file an appeal against the Judgment before the Cassation Court, within a period of 30 days and in accordance with the UAE procedural laws.</p> <p>The Company had also filed a Petition under section 9 of Arbitration and Conciliation Act, 1996 before Hon'ble Delhi High Court. The Hon'ble Delhi High Court subsequently allowed the petition and granted an anti-enforcement injunction to the Company restraining RSM to enforce any judgment or decree passed by the Dubai Courts.</p> <p>It is imperative to clarify that due to the pendency of the arbitration proceedings in India instituted by the Company, any judgement/orders passed by the Dubai Courts will not be executable in India till the arbitration proceedings are concluded or in UAE, till the appeal filed by the Company is decided by the Cassation Court, along with a review of such appeal by the Cassation Court, if filed by the Company.</p>
